



ADMIXTURE S/F (SILICATE FREE) LIFETIME WARRANTY

Lifetime Warranty: Concure Systems, LLC warrants its admixture, when dosed, mixed, and dispensed according to industry guidelines (ACI/RFCI) for w/c ratio and slump for all interior slabs to receive flooring, and used in conjunction with 670 Crack Fill Binder, will perform in accordance to Concure's requirements for stopping moisture migration out of the concrete itself and or from a ground source for the lifetime of the slab and that the admixture will be free from all manufacturers' defects. Any use of petroleum products, paraffin, de-bonding agents, cleaning agents, oils, grease, dirt, or foreign products will void the lifetime warranty.

Limitations of Lifetime warranty: If a claim is made, Concure Systems, LLC reserves the right to inspect and test any and all materials related to the claim to determine the source of the problem. If a claim is determined to be moisture migration through or out of the slab, Concure Systems, LLC will mitigate the affected areas using Concure Systems Vapor Barrier Plus topical system. Concure Systems will seal, repair and/or replace all floor covering materials in the affected areas only, with the same or comparable products and shall not exceed the value of existing materials and labor. Concure Systems, LLC makes no other warranty expressed or implied and is not responsible for substandard concrete workmanship in finishing, curing, floor cracking, control joints or expansion joints* as a source of moisture migration, or other types of concrete additives used. The sole and exclusive remedy of purchaser, for any claim concerning this product, but not limited to, claims alleging breach of warranty, **negligence**, strict liability or otherwise, is limited to the resealing of the concrete slab and replacement of damaged floor covering materials, at the sole option of Concure Systems, LLC. All Claims concerning this product shall be submitted in writing within a 60 days of time of discovery. In no event shall Concure Systems, LLC be liable for any special, incidental, consequential or punitive damages, including loss of profit and use.

Warranty Issuance: Warranty will be issued and honored from Concure Systems, LLC when receiving the following documentation: Concrete mix design, cement truck tickets filed, engineer evaluations and reports, confirmation of compliance with strict cement to water ration guidelines by concrete supplier and installer. Prior to installation of floor coverings a material bond test (ASTM D-4263) must be performed according to the resilient Flooring institute guidelines and manufactures specifications. If tests are not performed prior to installation it will affect the lifetime warranty. Tests must be performed by a certified flooring contractor and all test results must be registered with Concure Systems, LLC prior to installation of products.

Concrete moisture testing: Floorcovering manufacturers only have recommendations, **NOT REQUIREMENTS** for acceptable moisture levels to prior to installation. Because the slab containing Concure Systems Admixture creates a nonporous slab Calcium Chloride, Rh testing will give false results. No test result from this type of testing will void our permeability warranty. Concure Systems, LLC will issue its warranty with regard to moisture migration through or out of the slab under the results of ASTM D-5084 and ASTM D-4263-modified (mat-glue). All accounts must be paid in full prior to any warranty being issued or enforced.

In the event of a claim and notification: Concure Systems, LLC reserves the right to have an authorized Concure Systems, LLC representative inspect and verify any issues due to moisture migration through or out of the slab under the terms of the lifetime warranty. Any costs incurred without written consent or approval from Concure Systems will not be honored for payment.

***Expansion, control joint warranty:** Concure Systems, LLC will warrant any and all expansion joints, control joints or cracks from moisture migration for the lifetime of slab when applying Concure Systems 670 Crack Fill Binder according to the manufacturer's recommendations, installation guidelines and proof of purchase.
